### **Fees**

- Rent ..... \$10.00 / acre (minimum \$50.00)
- Cleaning fee..... \$50.00
- Penalty for using  
fertilizer in seed box..... \$100.00 (future rental will be denied)
- Late return of drill ..... \$50.00 per day
- Late payment fee..... 1.5% monthly after 30 days

- 1.** A representative from the Adams SWCD, hereinafter referred to as the District, will review operation instructions before use. The No-Till Drill will not be used in areas where damage to the drill could result from rocks, roots, stumps, steep slopes, debris, or other material. If the drill is damaged, you will be billed for repair costs. User assumes all liability for damages to or caused by or through the operation of this equipment.
- 2.** All needed repairs must be reported to the District and those repairs will be performed by the District unless otherwise stated.
- 3.** This equipment must not be towed at a speed of more than 20 mph.
- 4.** If transporting equipment to a different field / location, the drill must be in transport position before leaving the field or the acre meter will continue to run during transport and you will be billed for the total acres indicated.
- 5.** Assistance with adjustments and instructions for use will be furnished by the District. The user is not to operate the drill without this assistance provided.
- 6.** I assume full liability and responsibility for damages to, or caused by District equipment (beyond normal wear), from the time I obtain the equipment until it is returned to the District.

7. I will provide transportation to and from the designated point of storage or pickup. All necessary measures will be taken to ensure the proper transport of the equipment.
8. I agree to clean all seed from seed boxes and any mud or debris from the coulters when finished. A charge of \$50 will be assessed if the equipment is not properly cleaned after use.
9. A Rental Agreement must be signed every time a piece of equipment goes out. Subsequent uses will also require a new agreement and be subject to usage minimums. Sub-rental or loaning to another party is strictly prohibited.
10. I agree to use the equipment immediately, weather permitting, and return the equipment to the District promptly after use. A \$50 per day fee will be charged for equipment kept longer than 48 hours (unless other arrangements are made). The District will be notified at 937-544-1010 when finished with equipment so that the next renter may be notified.
11. All payments must be paid within 30 days from invoice date, or date of equipment return, or a 1.5% interest will be added to your account. The District will turn any or all accounts over to the Adams County Prosecutors Office if not paid in full.
12. I certify that I have liability insurance on the vehicle used to transport the equipment, and this insurance also applies to the equipment being towed with the vehicle.
13. I agree to indemnify and hold harmless the District and the County of Adams, Ohio, their agents, employees or any other person against loss or expense including attorney fees, by reason of the liability imposed by loss upon the District and County, for damages because of bodily injury, including death at any time resulting there from, sustained by any person or persons, or on account of damage to property arising out of the transportation or the use of equipment rental, leased or borrowed from the District.
14. The No-Till Drill equipment will be covered with the tarp (provided) or placed inside a dry building when not in use.
15. The District may remove or deny the use of the equipment at the District's discretion.
16. All of the equipment will be transported during daylight hours only!!!
17. Fertilizer will not be used in boxes. Boxes are for seed only. A cleaning fee of \$100 will be assessed if fertilizer is used in boxes and future rental will be denied.
18. Additional fees may apply if location is outside Adams County.
19. **Note:** Lights extend beyond the width of the drill. Allow for sufficient clearance when moving.
20. Make sure that end of **hydraulic hoses and outlets are clean** before connecting to tractor.
